

1. GENERAL TERMS AND CONDITIONS

1.1. By using or visiting any part of the website betboom.com or by creating an account on the website, you agree to the following:

- Terms and Conditions;
- personal data protection policy;
- Privacy Policy;
- rules of any of the games;
- promotional terms, bonuses, and special offers that can be found on the website.

All terms and conditions listed above are hereinafter referred to as "Terms and Conditions". Please read the Terms and Conditions carefully before accepting them. If you do not agree to accept and comply with them, please do not create an account and do not continue to use the website. Your further use of the website will constitute your acceptance of these Terms and Conditions. The Terms and Conditions come into force on November 1, 2019.

2. PARTIES

2.1. The company is fully licensed and regulated by the laws of this country. Excerpts from these terms and conditions containing the pronouns "us", "our", "we" or "company" refer to the respective company with which you are entering into an agreement in accordance with the paragraph above. 3. AMENDMENTS TO THE TERMS

3.1. The Company reserves the right to amend, edit, update, and change the Terms and Conditions for a number of reasons, including commercial, legal, and customer service reasons. The updated Terms and Conditions and their effective dates are available on our website. We will notify the customer of any amendments, updates or changes by posting a new version of the Terms and Conditions on the website. The gamblers are responsible for familiarizing themselves with the current Terms and Conditions. The Company advises customers to regularly check for updates to the Terms and Conditions. The Company reserves the right to introduce any amendments to the website operation, software, and the procedure for providing services, as well as to update the requirements that must be met in order to access and use the services in accordance with current legislation, at any time and without prior notice.

3.2. If you do not agree to the amendments, you may stop using our website and close your account by complying with Clause 13 of the present Terms and Conditions. Your

continued use of any part of the website after the effective date of the revised Terms and Conditions will automatically be deemed as acceptance of the revised Terms and Conditions, including any additions, deletions, replacements, or other changes to the identifying information relating to the company referred to in paragraph 2.1 of the present Terms and Conditions, regardless of whether you have received the notice or read the revised Terms and Conditions or not.

4. LEGAL REQUIREMENTS

4.1. The Company reserves the right to request proof of your age at any stage to ensure that persons under the legal age do not use the website services. The Company has the right to suspend your account and refuse the service if proof of age is not provided or the Company suspects that the service is being used by a person who has not reached the legal age.

4.2. Online gambling may be illegal in some jurisdictions. You understand and accept that the Company is unable to provide you with legal advice or guarantees regarding the legality of your use of the website services. The Company does not claim that the website services comply with the laws of your jurisdiction. If winnings are subject to taxation by your local legislative, tax, and other authorities, you are responsible for reporting your winnings and losses to the appropriate authorities.

4.6 The company reserves the right to conduct additional checks, including video verification. In case of failure to pass video verification, the company has the right to block the client.

5. ACCOUNT REGISTRATION

5.1. The customer needs to register an account using an email address, mobile phone number, or social media page in order to be able to use the website services.

5.2. The user confirms that when registering on the website, they provide accurate and reliable information about themselves, and in case of any changes, they will update this information respectively. Failure to do so may result in the application of restrictions, non-execution of transactions (bonuses, winnings), suspension of your account, or inability to provide assistance in recovering your password.

5.3. The customer confirms that they are at least 18 years old and have reached the age of majority that is legally permitted to participate in gambling under the laws of their jurisdiction.

If we are unable to verify that you are of legal age, we may suspend your account, and all bets and winnings may be forfeited.

The list of prohibited territories may be updated.

5.5. Only one account is allowed per player, per address of residence, per IP address, and per device. If a user attempts to create more than one account, those accounts may

be banned or suspended, and any bets cancelled. Any deposits, winnings, and bonuses received with duplicate accounts may be forfeited. To create a new account, for example, in case of loss of access to the main account, the user must mail a corresponding request to support@bet-boom.com

After opening a new account, the former one will be blocked. If the user notices they have several accounts, they must immediately notify betboom.com about this. Otherwise, the player's accounts may be suspended.

5.6. [Betboom.com](http://betboom.com) prohibits customer collusion, as well as the use of any kind of robots or programmed devices in the game. We reserve the right to cancel the results of the game in such circumstances.

5.7. The customer must provide a username and password during the registration process. Ensuring the safety and security of the credentials is a matter of personal disciplinary responsibility. The user must not disclose their personal details. [Betboom.com](http://betboom.com) is not responsible for the abuse of the account by third parties if the customer transferred his personal data.

5.8. You agree that it is your responsibility to immediately notify the Company of any unauthorized access to your account or any breach of security by sending a message to support@bet-boom.com.

5.9. If you have lost or forgotten your credentials, you can recover your password by clicking on the "Remember password" button below the login window.

6. ACCOUNT VERIFICATION

6.1. [Betboom.com](http://betboom.com) has the right to carry out additional procedures and means of confirming the identity of the client at any time. Both when processing withdrawals and when crediting deposits.

6.2. The following documents are required for verification:

- photo of the identification document: ID card/passport
- selfie with identification card/passport
- e-wallet

The details in the documents must be clearly visible on the photo. Make sure that there is no glare on the photos. Selfies with documents must show your face and data clearly. We only accept photos of original documents. Photographs of copies, certificates of loss and temporary documents will not be accepted.

6.3. The Casino reserves the right to request confirmation of the address of residence - This may be a rent bill, Wi-Fi payment, a bank statement (where the address of residence is indicated), an agreement with a mobile operator or other document.

Please note that a document confirming the address of residence must be received no later than 90 days.

6.4. We may limit the activities on your account during the verification.

6.5. If any of the information you provide appears false, inaccurate, misleading, or otherwise incomplete, or the information you provide does not match the information in your passport details, we reserve the right to immediately block your account and refuse to provide the website services for you, in addition to any other action in our discretion.

7. USERNAME, PASSWORD, AND SECURITY

7.1. You must not disclose your username and password to anyone after the account creation. If you have lost or forgotten your account information, you can reset your password by clicking on the "Can't log in" link located below the login window.

7.2. You are solely responsible for keeping your password secure and for any activity or transactions made on your account. You are also responsible for all losses on your account that you incur due to the actions of third parties.

7.3. You accept the responsibility to immediately notify the Company of any unauthorized access to your account or breach of security via support@bet-boom.com. You agree to provide the Company with evidence of such unauthorized access, if required. The Company is not responsible for damages incurred by you as a result of your credentials misuse by another person or for unauthorized access to your account, regardless of whether they were authorized by you or without your knowledge.

8. DEPOSITS

8.1. Betboom.com is not a financial institution. The funds in the customer's account do not earn any interest and cannot be converted between the currencies available on the website.

8.2. The user can take part in the games on the website only if there is a sufficient amount of funds on their account.

8.3. To deposit funds into account, the customer can transfer them from their personal electronic wallet or account through one of the available payment systems. It is allowed to use only bank cards or electronic wallets belonging to the user personally for making deposits. The full name of the bank card holder, as well as personal details in the profiles of any other means of payment used for deposits or payments, must match the user personal details. If we detect a violation of this condition during a security check, all winnings may be confiscated, and the account can be suspended.

8.4. If the customer makes a deposit using a bank card, then the cardholder name must be real and indicated in accordance with the following requirements:

- the field must contain at least 2 words;
- no more than one dot;
- the length of each word must be at least two characters;
- use letters of the Latin alphabet only;

- combinations of the following characters in words and the words themselves cannot be used: “BANK”, “VISA”, “MASTER”, “MAESTRO”, “CARD”, “MOMENT”, “TEST”, “PAYMENT”, “GOLD”, “NAME”, “MC”, “INSTANT”, “EXPRESS”, “EXSPRESS”, “HOLDER”, “DEPOSIT”, “DEBIT”, “CREDIT”, “UNIVERSAL”.

In this case, the supporting documents must be provided if the first or last name of the customer coincides with one of the words indicated above – for example, "Masterov". Please note that the issuing bank or an external provider on their side can perform an additional check of the “holder” parameter and suspend payments on their side.

8.5. The user confirms that the origin of the funds used to top up the account balance is not illegal or unauthorized.

8.6. Betboom.com reserves the right to use additional procedures and means of verifying the customer identity when crediting deposits to the user's account. This may include, for example, a photo of the user with an identity document. Please see the "Account Verification" section of the current Terms and Conditions for more information about the identity verification procedure.

8.7. The User undertakes not to refuse previously conducted transactions, not to cancel them in any way, not to cancel any deposit operation, and to refund and compensate Betboom.com for any expenses incurred by us in the process of making these deposits and returns.

8.8 Money deposited in the casino must be used for gaming activities. Your deposit must be wagered three (3) times for Slots or ten (10) times for the Sports and Cybersports section.

Deposit Wagering Rules:

- Deposit wagering is only available in Slots, Sports and Cybersports.
- Deposit wagering in all other types of games is 0%.
- Bonus money bets are not counted in the wagering deposit
- When betting on Sports/Cybersports, the amount of the bet is taken into account **with a coefficient of 1.3**. Bets with "Refund" and "Cancel" statuses are not taken into account.
- Lost deposit is not subject to wagering

8.8.1 In case of detection of a scheme where a player makes minimum deposits in order to avoid wagering the last large deposit, the Company has the right to request wagering of the amount of deposits made since the last withdrawal, and in case of absence of payments - since the first deposit.

8.9. The Company may reward the customer a bonus under certain circumstances. The conditions for receiving a bonus and its size are displayed in the "Promotions" section on the website or in the "Bonuses" section in your account. If the account has both cash and bonus funds, then the bonus funds will be available for play only after the real funds run out. If the customer withdraws the principal amount of the deposit

before the bonus wagering requirements are met, then the bonus funds and any winnings received when playing with the bonus will be deducted from the balance.

8.10. If you try to make a deposit using cryptocurrencies and have not completed the transaction, the commission for the return of this deposit is borne by the customer.

9. PAYOUTS

9.1. You may submit a withdrawal request at any time, provided that all payments made to your account have been checked for unacceptable activity and no payments have been canceled or otherwise reversed.

9.2. We agree on payments up to 24 hours, but we try to do it as soon as possible. If additional verification is required by the provider, the payment period can be extended up to 30 days.

9.3. We reserve the right to carry out additional verification procedures when processing payouts. This may include a request for additional documents.

9.4. The withdrawal must be made to the same means of payment that was used for the deposit. For example, if the winnings were received when betting a deposit made from a Visa card, then the payout must be made to the same Visa card.

9.5. Please note that external payment processors and the User's Bank may charge a fee when processing payments. In the case of deposits or withdrawals with currency conversion, the difference will be deducted according to the exchange rate at the time of the transaction.

9.6. Withdrawal amounts are limited to 5 000 USD per day (or equivalent in another currency), 15 000 USD per week and 50 000 USD per month, unless otherwise specified in the rules of a particular promotion. However, exceptions may be made for players with VIP status.

If the winnings exceed 50 000 USD, the casino reserves the right to divide the payout into monthly payments of no more than 50 000 USD until the entire amount is paid.

The casino can change the withdrawal limits unilaterally, including individually for individual players, without changing the rules. The limits for withdrawal of funds after large winnings will be set individually for each player who received a large win.

9.7. If any funds or bonuses have been mistakenly credited to the customer's account – for example, due to a technical error in the winnings table or an error caused by a human factor, then such funds or bonuses remain the property of the Company and will be debited from the account. If the customer withdraws funds that do not belong to them before the error is detected, then the erroneously paid amount will be considered as the customer's debt to betboom.com, without prejudice to the legal rights of the user. The customer is obliged to immediately notify the support service of our company via support@bet-boom.com or via online chat in case of an erroneous deposit to the balance.

9.8. If suspicious activity is detected, additional verification may be required and the payment period may be extended up to 180 days.

10. GAME RULES AND BETTING ON THE WEBSITE

10.1. You are responsible for ensuring that the details of any of your transactions are correct before confirming your bet in the game.

10.2. There are restrictions on the minimum stake. By default, the minimum stakes are as follows: 0,05 EUR, 0,05 USD, 0,2 PEN, 45 CLP, 0,25 BRL, 6 ARS, 1 MXN.

10.3. There are restrictions on the maximum stake in slots. By default, the maximum stakes are as follows: 5000 EUR, 5000 USD, 18 900 PEN, 4 010 000 CLP, 26 300 BRL, 1 028 900 ARS, 92 400 MXN.

10.4. There are restrictions on the maximum stake in bingo, live casino and TV games. By default, the maximum stakes are as follows: 100 EUR, 100 USD, 385 PEN, 90 000 CLP, 510 BRL, 13 695 ARS, 2 000 MXN.

10.5. The history of your transactions can be found at the link "History of bets" in the Balance section in your account on the website.

10.6. If you have violated these Terms and Conditions, we reserve the right to refuse any transaction requested by you through the website, in whole or in part, at any time. No transaction is considered accepted until you receive the confirmation from us. If you have not received the confirmation that your transaction has been accepted, you need to contact our support service.

10.7. The bet cancellation becomes effective only after we send you the cancellation confirmation. If the request to cancel a trade is not received or processed in a timely manner, you agree that your bet may remain pending and be available for acceptance.

11. COLLUSION, MISLEADING ACTIONS, FRAUD, AND CRIMINAL ACTIVITIES

11.1. The following activities are not permitted and constitute a substantial breach of the Terms and Conditions:

- disclosing information to third parties;
- use of malware and automated players, exploiting bugs in our software;
- fraud on your behalf, including using stolen, cloned, or otherwise illegally obtained credit or debit card information to top up your account;
- participation in any criminal activity, including funds laundering or any other activity with criminal consequences;
- colluding or intending to directly or indirectly engage in any collusive scheme with another player while playing on the website.

11.2. We reserve the right to suspend, withdraw, or cancel any payments or winnings associated with bonus funds received from the Company, such as experience points or bonuses, if we suspect that you are trying to abuse them.

11.3. In case of detection of a fraudulent game scheme or incorrect actions that were committed in order to receive a win by fraudulent means, the Company reserves the right to delay the payment for up to 180 days, for a detailed check of the gaming activity. If a fraudulent game scheme is confirmed, We reserve the right to recalculate the bet with x1 coefficient or cancel the winnings.

11.4. The Company will take all reasonable measures to exclude and identify collusions and their participants; appropriate action will be taken against such persons. We cannot be held responsible for any loss or damage suffered by you or any other player as a result of collusive, fraudulent activities and other illegal transactions or deceit; any action taken in this regard will be in our sole discretion.

11.5. If you suspect that someone is colluding or engaging in fraudulent activity, you must notify us via email as soon as possible.

11.6. We may terminate your access to the website services at any time, without prior notice and block your account if we suspect you of fraudulent activity. In this case, we disclaim the obligation to return or otherwise compensate the funds in your account. We also reserve the right to inform the relevant authorities, and you are obliged to cooperate with the Company in investigating this situation.

11.7. You are prohibited from using our services or software for any illegal or fraudulent activity, or for any illegal or fraudulent transaction, including funds laundering, under the laws of your country of jurisdiction. The Company reserves the right to suspend or block any of your accounts in the system at any time and withhold funds. In this case, you undertake to waive any claims against the Company.

11.8. The standard wager for players is x3 for slots, x1 for sports/cybersports with a 1,3 coefficient. If a player is suspected of fraud actions (determined to be a cheater), his wager will be changed to 30x for casino, and 20x for sports/cybersports.

12. OTHER PROHIBITED ACTIONS ON THE WEBSITE

12.1. It is forbidden to use offensive or aggressive manner of communication or images, profanity, threats, humiliation, or violent actions towards other players and Company employees.

12.2. It is forbidden to upload information to the website in such an amount that may cause malfunctions of the website, as well as to take any actions that may affect the operation of the website in any way, such as the use or distribution of viruses or similar malicious software. Any mass mailing of information is strictly prohibited. It is forbidden to interfere with or distort, delete, or otherwise alter any information located on the website.

12.3. You agree to use the Website for personal entertainment purposes only, and you may not copy the Website or any part of it in any form without our prior written consent.

12.4. You agree not to hack, attempt to hack, access, or otherwise circumvent our security system. If we suspect that you have attempted or are attempting to hack, access or otherwise bypass our security system or software, we will immediately terminate your access to the website services and suspend your account. We also reserve the right to inform the relevant authorities.

12.5. 13.1. You have the right to close your account at any time by contacting us by email: kyc@bet-boom.com. The letter must be formatted as follows: in the subject line, indicate «Account blocking». In the message itself, your login, the reason for blocking the account and the blocking period.

13.2. Until you get a confirmation that your account has been terminated, you are responsible for any activity on it from the moment you emailed us till the moment your account was terminated by the Company.

13.3. The Company reserves the right to withdraw a commission or the amount you owe the Company before your account is terminated. In the event that your account is deleted, blocked or canceled, no funds that were at the time of closing your account shall be refunded, and no other funds, such as bonuses, additional points, etc., shall be credited to you or cashed out, and further access to your account will not be possible.

13.4. Based on these Terms and Conditions, neither party has any further obligations towards each other in the event of your account cancellation.

13.5. The Company may block or terminate your account, including your credentials immediately without notice in the following cases:

17. BREACH OF THE TERMS AND CONDITIONS

17.1. You agree to fully indemnify us for any legal claims, liability, costs, or expenses, including legal fees and any other costs that may arise as a result of your breach of these Terms and Conditions:

- your violation of the Terms of Use;
- your violation of the law or the rights of third parties;
- use of access to the services by any other person using your user credentials, with or without your permission;
- acceptance of any winnings received in this way.

In cases where you violate these Terms and Conditions, we reserve the right to do the following:

- send you a notice that you break the Terms and Conditions and demand that you stop violating;
- suspend your account;
- block your account without prior notice;
- withdraw the amount of payouts, bonuses or winnings that you have acquired as a result of any violation from your account.

17.2. We have the right to block your account if you fail to comply with any of the Terms and Conditions.

20.2. You agree that the records on the server will act as the final evidence in determining the outcome of any claim in the event of any dispute.

20.3. You acknowledge that outcome of the games on the website is determined by our random number generator, which randomly generates events, and you accept the outcome of all games. In case of any discrepancy between the game results on your computer and the results on our server, the results on our server will be final and binding. In case of discrepancies between the information displayed on your screen

and the balance in your account, the balance available on the Company's server is considered the balance in your account, and this decision shall be final and binding. Any amounts from your account will be lost if the result is human error or technical failure.

21. INTERPRETATION

21.1. The original text of the Terms and Conditions is written in Russian, and any interpretation thereof must be based on the original Russian language. If the Terms and Conditions or any documents or notices associated with them are translated into any other language, then the Russian version takes precedence.

22. TRANSFER OF RIGHTS AND OBLIGATIONS

23.1. 24.1. If we fail to secure the strict performance of any of your obligations or we fail to exercise any of the rights or legal remedies to which we are entitled, this in no way constitutes a waiver of such rights or legal remedies and does not relieve you of such obligations.

24.2. None of our waivers of any of the obligations of the Terms and Conditions shall be legally binding unless formally worded and communicated to you in writing in accordance with the foregoing.

- Live Casino section - 0%
- Live-games / TV-games section - 0%
- Aviator - 0%

- Sports and Esports - 0%

28.2. Wagering bonuses for the Sports/Esports sections:

Wagering takes into account 100% of all bets.

Categories not available for wagering: eFootball and eBasketball.

Compliance with the bonus wagering requirements must occur within the validity period of the bonus activated by the player. Bets can be made on events, the calculation of which comes within the framework of the bonus.

At the end of this period, the bonus account is automatically reset by the system, and all winnings at unsettled rates from the bonus account are burned out.

28.3. Experience and levels.

The Company rewards loyal and regular players, providing them with the opportunity to earn experience points – EXPs, which are used to level up their status in the casino. EXPs are accumulated automatically when making bets from the player's real balance. You will be awarded a certain level depending on the amount of EXPs accumulated during the game. The player receives individual privileges, additional promotions, and bonuses with each new level.

28.4. Cashback.

- 3.5 PEN;
- 5 BRL;
- 200 ARS;
- 18 MXN;

28.4.2. Returns are not available for players with a disabled ability to receive gifts for any of the reasons, as well as for players with a temporary or permanent account block.

28.4.3. Some free spins (both stand-alone bonuses and those included in the deposit bonus) can be credited in stages: the first part is received immediately, and the rest is received after 24 hours.

28.5.
